**DESCRIPTION:** Rolling course winding thru New Glarus countryside. Maximum grade 8%.

**ABR/MATTs and WISPORT/OPEN RACE CATEGORIES:** G&B Juniors Under15, 15-18,  
M&W 19-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-74, 75-79, 80-84, 85-89, 90+

**ABR/MATTs ONLY:** Recumbent & Tandem; Men & Women Cat. 1/2, 3, and 4/5

**REGISTRATION & SIGN-IN:** Glarner Park (not Village Park) 3rd St. & 4th Ave. near Fire Department

**START:** NE Corner of 2nd St & 1st Ave. at north end of Village

**FINISH:** Village limits on 2nd St./Cty O at the green NEW GLARUS sign

**SHORT COURSE (18 Km/11.1mi) One Loop:** Start at intersection of 2nd St. & 1st Ave., go NW on 2nd St./Cty O, for 4.8 mi., turn left (SW) onto Hustad Valley Rd., turn left (SE) onto Pioneer Rd., turn right (SE) onto Cty. O, go 1.5 mi. to finish line at the green NEW GLARUS sign.

**LONG COURSE (31 Km/19.2mi) Two Loops:** Start at intersection of 2nd St. & 1st Ave., go NW on 2nd St./Cty O, for 4.8 miles, turn left (SW) onto Hustad Valley Rd., turn left (SE) onto Pioneer Rd., turn left (N) onto Cty. O, turn left (SW) onto Hustad Valley Rd., turn left (SE) onto Pioneer Rd., turn right (SE) onto Cty. O, go 1.5 miles to finish line at the green New Glarus sign.

**DISTANCES:** Juniors U15 & Masters 70+: **18 Km/11.1 miles**. All Others: **31 Km/19.2 miles**

After July 19 adults \$35 and Juniors \$20. \$10 for 2nd race (see below).

**SECOND RACE:** Sign-up for USAC/WCA\* time trial by Thu. July 19th then sign-up for ABR/MATTs or WiSport/Open\*\* race on site for \$10. Estimated starting time for second race: 10:30AM.

\*ABR membership for ABR categories required: Annual=\$25; Juniors<19 Annual=\$10; One day=\$5
